Wendy has contributed to national research projects on stroke recovery, oral health, and blood pressure technology, and regularly supports physiotherapy education. Her lived experience has shaped impactful patient involvement in innovation and research. Wendy's dedication has been recognised through awards and published contributions, empowering stroke survivors and improving care across the UK.

Tom Riordan, Second Permanent Secretary, Department of Health & Social Care

Tom Riordan joined the Department of Health and Social Care as Second Permanent Secretary in September 2024, where he has led on Adult Social care and the 10 Year Health Plan, among other government priorities. Prior to this appointment, he was the Chief Executive of Leeds City Council for 14 years, during which time he led the regeneration of Leeds city centre and modernised services to improve children's services and pioneer the Home First adult social care programme.

Tom undertook a secondment to NHS Test and Trace in 2020. His earlier career included his role as Chief Executive of Yorkshire Forward between 2005 and 2010, and earlier roles in the Department for Environment.

Professor Tony Young is a practising NHS consultant urological surgeon, Associate Medical Director, and Director of Medical Innovation at Anglia Ruskin University. He founded four Med-Tech start-ups and became the NHS's first National Clinical Lead for Innovation in 2014. Tony founded the NHS Clinical Entrepreneur Programme, now the world's largest of its kind. Awarded an OBE in 2019, he leads national programmes including the Innovation Accelerator, SBRI Healthcare, and the Innovation and Technology Payment. His work spans health, social care, public health, and life sciences, driving innovation, economic growth, and improved patient outcomes across the NHS.



Jack Porter, Co-Director, NHS Innovation Accelerator

Jack is Co-Director of the NHS Innovation Accelerator (NIA), where he leads system engagement and works closely with partners across Integrated Care Systems, NHS England, and the Health Innovation Network to scale high-impact solutions developed by NIA Fellows.

He began his career in finance with the Roche Group, gaining experience across Diagnostics and Pharmaceuticals in both Europe and North America. Jack later transitioned into digital health, where he led commercial strategies for several health tech start-ups—from early-stage ventures to successful exits—including HealthUnlocked, a former NIA Fellow and the world's largest social network for health.

Before joining the NIA, Jack held a leadership role at Novartis Biome, overseeing national initiatives such as the rollout of patient management technologies and at-home testing solutions.

Dr Nicola Hutchinson is CEO of Health Innovation North East and North Cumbria and was part of the original team that secured accreditation for the Academic Health Science Network, back in 2013. She advises the North East and North Cumbria ICB in relation to innovation and serves as a Trustee of the Percy Hedley Foundation. Nicola is passionate about innovation and its associated impact, honouring her late brother, Steven through her work.

Vlad has a background in organic, synthetic chemistry with over 20 years experience in the personalised diagnostics field. Throughout his research career, Vlad has published more than 50 research articles and has been cited more than 2000 times.

Laura Earnshaw is founder of <u>myHappymind</u>, an award-winning, NHS-backed curriculum for primary schools and nurseries that teaches children lifelong habits to have good self-esteem, resilience and ultimately good mental health.
