The AAC operates at many levels, with opportunities to get involved from all parts of the health and care ecosystem.

The AAC Board

Has now agreed its expanded remit and set its priorities for the next year. In the autumn, they will finalise a detailed plan that describes support for early-stage products, how patients will be involved in making decisions across all levels of the AAC, and consider the plan for supporting the Prime Minister's ambitions on Artificial Intelligence.

The AAC Steering Group

Chaired by Dr Sam Roberts, and reporting to the board, the steering group oversees the AAC's programmes of work. It ensures consistency with the AAC Boards vision by directing and coordinating AAC task-and-finish and oversight groups (such as the NHS adoption products group, and the Early Access to Medicines Scheme) that bring together senior-level representatives from government, regulatory bodies, patient/charity groups and industry.

Task and finish groups

These undertake specific work. Such groups focus on individual priorities, such as establishing a funding mandate, and bringing together horizon-scanning infrastructure. These groups frequently reach out to patients, clinicians, innovators/industry groups and regulatory teams, both formally and informally.
